Summary of Meetings and Activities Held/To Be Held (from Oct. 2016 through Oct. 2017):

In conjunction with the 3rd Ceramics Expo in Cleveland, Ohio, April 25-27, 2017, the ACerS Manufacturing Division hosted a division lunch and meeting to update its membership on their activities throughout the past year. Over 50 members attended the luncheon, and offered suggestions for member engagement, webinar topics and increasing overall division membership.

The division's Programming Committee organized sessions before and during Ceramics Expo: two targeted learning workshops, three sessions at Ceramics Expo and the 6th Ceramic Business and Leadership Summit featuring industry leaders and technical, hands-on sessions.

Since its inception in 2015, Ceramics Expo's attendance has increased from 2,117 attendees to 2,800 attendees in 2017. Exhibitor participation has also risen from 171 in 2015 to 326 in 2017. The expo brings together the ceramics industry, is a key marketplace and features manufacturing technologies.
